# REGULATIONS 2024

## **GENERAL PROVISIONS**

### Purpose and Applications

These Regulations for the Women's Premier League (WPL) are promulgated by the Football Association of Singapore (FAS) to regulate and govern the conduct, operations, and administration of the WPL, all Clubs, League and Club Officials, Match Officials, Referees, Players, and other related stakeholders as cited within these Regulations.

### Scope of Application

These Regulations shall be used at all times in conjunction with all other governing documents and regulations of the WPL as issued from time to time. These Regulations shall be binding on the WPL, all Clubs in the Competition, League and Club Officials, Referees, Players and other stakeholders and partners as cited within these Regulations and other FAS governing documents.

### Enforcement

Any breach of any of the provisions of these Regulations shall be enforced by the imposition of action and possible sanctions pursuant to the FIFA, AFC and/or FAS Disciplinary Code as may be subsequently issued.

### Definition and Interpretation

Unless otherwise indicated, words and expressions in these Regulations shall have the same meaning as in other governing documents of the FAS. Any interpretation of provision of these Regulations shall at all times be the interpretation that best achieves the objectives of the FAS.

### Amendments

Any part of these Regulations may be amended from time to time, provided that any such amendments are formalized after appropriate consultation with the relevant committees of the FAS and approved by Exco.

## DEFINITIONS

In these Regulations, capitalized terms shall have the following meanings, unless the context specifically indicates otherwise:

For the purposes of these Regulations, and provided the context so permits:

- a) The singular shall include the plural and vice versa.
- b) The words "he" and "his" shall be used for any persons, whether male or female.
- c) Reference to natural persons shall include any legal person or corporation.
- d) References to the FAS shall include its successor and permitted assigns, and where the context requires, the FAS Committees.
- e) All defined terms, unless otherwise stated herein, shall bear the same meaning as ascribed in the FAS Constitution and the Manual, unless the context indicates otherwise.

## **SECTION A: COMPOSITION OF THE LEAGUE**

### **1. Composition of the League**

- 1.1. The FAS organizes, manages, and runs the Women's Premier League in Singapore, through a combination of football Clubs, known as the "Deloitte Women's Premier League", hereinafter known as Women's Premier League (WPL).
- 1.2. The League will include the following Competitions:
  - 1.2.1. Women's Premier League;
  - 1.2.2. Women's Challenge Cup;
  - 1.2.3. Any other Competition which the FAS may decide to organize;
  - 1.2.4. Any other Competitions which the FAS may sanction.
- 1.3. The above Competitions shall be governed by these Regulations and shall be played in accordance with the IFAB Laws of the Game.
- 1.4. These Regulations and all directives, decisions, guidelines, and circulars issued by the FAS shall be binding upon all parties participating and involved in the preparation, organization, and hosting of Matches in the Competition.
- 1.5. Any reference to the FAS Constitution, FIFA regulations and IFAB Laws of the Game refer to those valid at the time of application.
- 1.6. The Exco or the Council shall appoint a Competitions Committee, an Administrative and Finance Committee, a Marketing Committee, a Players Status Committee (PSC) or other Committee or Committees in their respective terms and Regulations there under, if any shall determine the format, timing, and venues of, and all other rules relating to Match or Matches, and any play-offs thereof, or regulating Players, Officials, or any other key personnel, their contracts of service, their registrations, administration and management thereof, and the use of the stadia or anything relating thereto, and/or anything relevant and desirable for promoting football in Singapore.
- 1.7. Such Committee or Committees, so appointed from time to time, shall promote, provide for, regulate, publish, where necessary, manage all or on any details or arrangements or other things necessary or desirable for or ancillary to the comfort, conduct, management, convenience or benefit of the game, the League and/or the Clubs thereunder and/or its members thereof.
- 1.8. Save as otherwise expressly provided for by these Regulations, all such decisions and ruling of the Committee shall be deemed to be decisions of the Exco or the Council as per these Regulations in these Sections hereinafter appearing, the Exco being deemed the supreme body and the final decider and/or decision-maker.

### **2. The Football Association of Singapore**

- 2.1. The FAS Competitions Department shall be responsible for organizing the Competition in accordance with the Manual and/or these Regulations.
- 2.2. The responsibilities of the FAS shall include, but are not limited to;
  - 2.2.1. Supervising general preparations and deciding on the Competition format, draws and entries to the Competition;
  - 2.2.2. Determining the Match Schedule;
  - 2.2.3. Selecting the Match venues for the Competition;
  - 2.2.4. Appointing of Match Officials for each Match;
  - 2.2.5. Choosing the official football and stipulated technical material;
  - 2.2.6. Reporting cases where appropriate to the FAS Disciplinary Committee;
  - 2.2.7. Replacing Clubs that have withdrawn from the Competition;

- 2.2.8. Dealing with cases of cancelled or abandoned Matches;
  - 2.2.9. Dealing with cases of Force Majeure; and
  - 2.2.10. Dealing with any matters not provided for.
- 2.3. All decisions made by the FAS Competitions Committee and/or FAS Competitions Department in relation to the Competition are final and binding and not appealable.
- 2.4. All decisions made by the FAS Disciplinary Committee in relation to the Competition are in reference to these Regulations and/or the FIFA/AFC/FAS Disciplinary Code.

### **3. Participating Clubs**

- 3.1. The principal obligations and responsibilities of each Club are stipulated in the Participating Team Agreement (PTA), these Regulations, the Manual, the FAS Constitution and all other FAS regulations, directives, guidelines and circulars.
- 3.1.1. Each Club shall submit a PTA in order to participate in this Competition.
  - 3.1.2. Each Club shall have made full payment and be cleared of all outstanding Sanctions/Offer of Compositions and/or Fines imposed prior to the submission of the PTA, in order to be eligible to participate in this Competition.
  - 3.1.3. The PTA and other such documents as requested by the FAS in relation to the PTA shall be completed and submitted to the FAS in accordance with the stipulated deadline provided by the FAS.
  - 3.1.4. Failure to submit a validly completed PTA to the FAS by the stipulated deadline shall result in the non-participation of the relevant Club.
- 3.2. Each Club shall ensure as a condition of its participation that every member of its Team Official Delegation is aware of and complies with the PTA.
- 3.3. In all matters and transactions relating to the League, each Club shall behave towards each other and FAS or its Departments or its Committees with utmost good faith.
- 3.4. Each Club shall undertake to:
- 3.4.1. Observe all obligations set out in the PTA, these Regulations, the Manual, the FAS Constitution and all other FAS regulations, directives, guidelines and circulars;
  - 3.4.2. Comply with the Laws of the Game;
  - 3.4.3. Accept that all the administrative, disciplinary and refereeing matters connected with the Competition shall be settled by the FAS in compliance with these Regulations;
  - 3.4.4. Observe the principles of fair play;
  - 3.4.5. Ensure the good conduct of its Team Official Delegation who are registered and any person carrying out duties on its behalf throughout the Competition;
    - 3.4.5.1. Failure to ensure the good conduct of its Team Official Delegation may result in the Club being issued with a fine;
    - 3.4.5.2. The FAS Disciplinary Committee may issue further sanctions at its discretion;
  - 3.4.6. Observe the Official Match Countdown and all other Match-related protocol notified by the FAS.
- 3.5. No Player, Officials, or agents shall by any means whatsoever unfairly criticize, disparage, belittle or discredit any other Club or FAS or its Departments and/or its Committee or in either case any of its directors, Officials, employees or agents or bring football into disrepute.
- 3.6. A Club shall not either during or after its membership in the Competition, disclose or divulge either directly or indirectly to any person, firm/company or otherwise make use of any confidential information as to the business or finance of the FAS or its Departments or its Committees or any of its dealings, transactions or affairs or as to any other matters which may come to its knowledge by reason of its membership without FAS's prior written consent, save as to statutory and regulatory authorities and to such employees of a team to whom such disclosure is strictly necessary for purpose of their duties and only then to the extent so necessary.



- 3.7. Each Club shall procure that each of its Players, Team Officials and employees are made aware of the provisions of Articles 3.5 and 3.6 above.
- 3.8. Membership of the League shall constitute an agreement between FAS and each Club, and between each of the Clubs, to be bound by and to comply with:
- 3.8.1. These Regulations (each as altered, revoked or added to from time to time);
  - 3.8.2. The FAS Constitution (each as altered, revoked or added to from time to time);
  - 3.8.3. Such other Regulations that are applicable to the Clubs partaking in tournaments organized and/or sanctioned by FAS;
  - 3.8.4. Such decisions of the Exco or the Council of FAS;
  - 3.8.5. The Laws of the Game as laid down from time to time by FIFA as adopted by FAS or otherwise;
  - 3.8.6. Such agreement shall have effect from the date of the Club's admission to the League and terminate upon the Club ceasing to be a member thereof (but without prejudice to any rights or claims which may have arisen in respect of circumstances prior to such a date and to any Regulations which, by their terms, establish rights and obligations applicable after such a date) and/or pursuant to any resolution of FAS, through the Exco and/or the Council.
- 3.9. Any Club found to be in breach of these Regulations herein shall be deemed guilty of misconduct.

#### **4. Entry**

- 4.1. Any Club participating in the Competition shall be affiliated to the FAS or receive an Official Notice of Invitation to participate by the FAS.
- 4.2. The Exco or the Council reserves before, during or after any Season, the right to determine at all material times and at their absolute discretion the membership of any Club in the League which fails to meet the criteria and/or requirements, from time to time, of FAS.
- 4.3. A Club eligible to participate in the Competition shall also be required to satisfy any other criteria for continuing its membership in the Competition as shall from time to time be sanctioned by the Exco or the Council and/or through the Regulations formulated and sanctioned by FAS Standing Committee.
- 4.4. Eligible Clubs shall complete a PTA and submit it to the FAS in accordance with Article 3 to confirm their entry into the League.
- 4.5. The name of the Clubs participating in the League shall contain and include any landmarks, roads, locations, associations and/or heritages located in Singapore.

#### **5. Withdrawal Prior to Commencement of the Competition**

- 5.1. Any Club that enters the League shall undertake to play all its Matches as set out in the Match Schedule, determined by the FAS Competitions Department.
- 5.2. If a Club withdraws from the League before its commencement, the Club shall be fined a minimum sum of Two Thousand Dollars (SGD\$2,000.00).
- 5.3. The FAS Competitions Committee may refuse any future application made by the Club to participate in the League and impose any other sanctions as the Committee may determine.
- 5.4. verThe FAS Disciplinary Committee may impose further sanctions in its discretion.
- 5.5. In the case of a Club withdrawing or being excluded from the League, the FAS Competitions Committee shall be responsible for making any necessary decisions, including but not limited to;

- 5.5.1. Replace the Club;
- 5.5.2. Change the Competition System;
- 5.5.3. Change the Regulations.

5.6. All decisions made by the FAS Competitions Committee in this regard are final and binding.

## **6. Withdrawal After Commencement of the Competition**

- 6.1. A Club shall be considered to have withdrawn from the League after its commencement if the Club;
  - 6.1.1. Withdraws from the League after it has commenced; or
  - 6.1.2. Does not report for a Match; or
  - 6.1.3. Refuses to continue with a Match; or
  - 6.1.4. Leaves the stadium prior to completion of a Match.
- 6.2. If a Club withdraws from the League after its commencement, the Club shall be fined a minimum sum of Three Thousand Dollars (SGD\$3,000.00), and the Club shall be suspended from participating in the League for a period of minimum One (1) Season, not including the Season in which the Club withdrew from.
- 6.3. The FAS Competitions Committee may refuse any future application made by the Club to participate in any Competition and impose any other sanctions as the Committee may determine.
- 6.4. The results of all Matches played by and against the Club prior to this withdrawal shall be declared null and void as if the Club had not participated in the Competition.
- 6.5. The results of all Women's Challenge Cup Matches played by and against the Club prior to its withdrawal shall stand and remain unchanged.
- 6.6. The Competition format, including but not limited to the relegation and promotion procedures, shall remain as stipulated in these Regulations and are not affected by the withdrawn Club, as if the Club had not participated in the League.

## **7. Expulsion of Club**

- 7.1. If a Club is expelled from the League, the following shall apply;
  - 7.1.1. The expelled Club shall be fined a minimum sum of Five Thousand Dollars (SGD\$5,000.00).
  - 7.1.2. The expelled Club shall not be allowed to continue its participation in the current Season of the League.
  - 7.1.3. The expelled Club shall not be allowed to participate in future Women's Premier League, Women's National League and Women's Challenge Cup Competitions for a period of minimum two (2) Seasons, not including the Season in which the Club was expelled from.
  - 7.1.4. Pursuant to Articles 7.1.2. and 7.1.3., the expelled Club shall, after having served the duration of expulsion, be allowed re-entry into the League only through the Women's National League, or any other qualifying Competition to the Women's Premier League which may be organized by FAS.
  - 7.1.5. The FAS shall withdraw any or all financial privileges given by the FAS to the Club for the entire period of expulsion.
  - 7.1.6. The results of all Matches played by and against the Club prior to its expulsion shall be declared null and void as if the Club had not participated in the League. The Club shall also lose its current position in the League standings and status in the League as if the Club had not participated in the League.

- 7.1.7. The Competition format, including but not limited to the relegation and promotion procedures, shall remain as stipulated in these Regulations and are not affected by the expelled Club, as if the Club had not participated in the League.
- 7.1.8. The results of all Women's Challenge Cup Matches played by and against the Club prior to its expulsion shall stand and remain unchanged.

## **SECTION B: COMPETITION SYSTEM AND MATCH SCHEDULE**

### **8. Competition System**

- 8.1. The League shall be spread over a minimum of six (6) months.
- 8.2. The FAS Competitions Department shall determine dates of commencement and conclusion of the League.
- 8.3. The Women's Premier League shall be played on a 'home' and 'away' round robin League basis.
- 8.4. Three (3) points shall be awarded for a win. One (1) point shall be awarded to both teams involved in a drawn Match, and no points shall be awarded to the losing team.
- 8.5. The team which accumulates the greatest number of points at the end of the Competition shall be declared Champion.

### **9. Tiebreaker Mechanism**

- 9.1. In the event that two (2) or more teams have accumulated a similar number of points, then the higher placed team shall be the team which has a greater goal difference i.e. number of goals conceded subtracted from the number of goals scored.
- 9.2. In the event that two (2) or more teams have a similar goal difference, then the higher placed team shall be the team which scores the greater number of goals.
- 9.3. In the event that two (2) or more teams score a similar number of goals, then the higher placed team shall be the team which attains the greater number of wins.
- 9.4. In the event that two (2) or more teams attain the same number of wins, then the higher placed team shall be the team which attains the higher number of points from the Matches played between the teams in question.
- 9.5. In the event that two (2) or more teams attain the same number of points from the Matches played between the teams in question, then the higher placed team shall be the team which has the greater goal difference from the Matches played between the teams in question.
- 9.6. In the event that two (2) or more teams have a similar goal difference from the Matches played between the teams in question, then the higher placed team shall be the team which scored the greater number of goals from the Matches played between the teams in question.
- 9.7. In the event that two (2) or more teams score a similar number of goals from the Matches played between the teams in question, then the higher placed team shall be the team which attains the greater number of wins from the Matches played between the teams in question.
- 9.8. In the event that two (2) or more teams cannot be separated using the above criteria, the winner shall be decided by the team having the higher standing in the fair play table (tabulation of Yellow and Red Cards).
- 9.9. In the event that two (2) or more teams have the same standings in the fair play table, a play-off shall determine the winner.

### **10. Promotion & Relegation**

- 10.1. There shall be no promotion and relegation of Women's Premier League or Women's National League Clubs for Season 2024.
- 10.2. The FAS Competitions Committee may in its absolute discretion make amendments to Article 10.1.

## **11. Match Schedule**

- 11.1. All Matches shall be played in accordance with the League's calendar.
- 11.2. All Matches shall, unless re-arranged with the approval of the FAS Competitions Department, be played on the dates and venues scheduled at the commencement of the Season.
- 11.3. The FAS Competitions Department retains the final discretion to amend the Match Schedule at any time.
- 11.4. All Matches may be arranged with a minimum of forty-eight (48) hours of rest for all Clubs between their previous and the next Match.
- 11.5. With the exception of extenuating circumstances, no request for postponement or rescheduling of a Match from a Club shall be permitted after the commencement of the League.
- 11.6. All Clubs shall submit any block-out date requests to the FAS Competitions Department at least one (1) month before the commencement of the League. All requests are subject to approval from the FAS Competitions Department and/or Committee.
- 11.7. A Club may request for a postponement and rescheduling of a Match if at least five (5) or more Players from their squad have been officially called up to represent the National Team or representative teams in any official International Match or International Competition.
- 11.8. All kick-offs shall adhere to the time stipulated by the FAS Competitions Department. In cases of inclement weather conditions, a minimum thirty (30) minutes grace period shall be observed. The Match Commissioners and Match Officials shall report any delays at the scheduled time of kick-off and the start of the second half.
- 11.9. Any Club causing a kick-off to be delayed beyond the stipulated time of kick-off shall be deemed guilty of misconduct. The FAS Competitions Department may impose any sanctions as it may determine and/or refer the Club to the FAS Disciplinary Committee for further sanctions.
- 11.10. All decisions made in this regard are final and binding.

## **12. Cancellation of Matches**

- 12.1. For any Match which is cancelled as a result of Force Majeure, the FAS Competitions Committee shall decide on the matter at its sole discretion and take whatever action is deemed necessary.
  - 12.1.1. Decisions made pursuant to Article 12.1 are final and binding and not appealable.
- 12.2. Any Match which is cancelled, except in cases of Force Majeure recognized by the FAS Competitions Committee, may lead to the imposition of sanctions by the FAS Disciplinary Committee against the relevant party that caused the cancellation.

## **13. Abandonment of Matches**

- 13.1. For any Match which is abandoned as a result of Force Majeure, the FAS Competitions Committee shall decide on the matter at its sole discretion and take whatever action is deemed necessary.
  - 13.1.1. Decisions made pursuant to Article 13.1 are final and binding and not appealable.

- 13.2. Any Match which is abandoned, except in cases of Force Majeure recognized by the FAS Competitions Committee, may lead to the imposition of sanctions by the FAS Disciplinary Committee against the relevant party that caused the abandonment.
- 13.3. An abandoned/postponed Match shall not be considered as the Match where a suspended Player has served the suspension; the suspended Player shall serve the suspension in the immediate Match following the abandoned/postponed Match. If an abandoned Match is to be replayed, any caution issued during that Match shall be annulled but a red card received by a Player in an abandoned Match shall count and the appropriate sanction shall follow. The replay of the abandoned Match shall not be considered as the Match where the errant Player has served the suspension. If the Match is not to be replayed, the cautions received by the team responsible for causing the Match to be abandoned are upheld; if both teams are responsible, then all of the cautions are upheld.
- 13.4. In the event where the Match is postponed or abandoned through the fault of a team, the result shall be decided by the FAS Competitions Committee as to whether there should be a replay. The Competitions Committee reserves the right to take whatever action they deem fit against the infringing team, including but not limited to imposing a penalty on the team.
- 13.5. If a Match is abandoned not as a result of Force Majeure, suspension is only considered to have been served if the team to which the suspended Player belongs is not responsible for the facts that led to the abandonment of the Match.
- 13.6. In the event where a Match is abandoned before the 80<sup>th</sup> minute of play (ie. Between 0 to 79 minutes) as determined by the Match Official, the Match shall be replayed. The score of the abandoned Match shall be considered null and void, and the replay shall start as a new Match playing the ninety (90) minutes of regulation time with a score of 0-0.
- 13.7. In the event where a Match is abandoned on or after the 80<sup>th</sup> minute of play as determined by the Match Official, the result of the Match shall stand, and the Match shall be deemed as played.

#### **14. Women's Challenge Cup**

- 14.1. Unless stipulated or expressed otherwise, The Women's Challenge Cup Competition shall be governed by these Regulations under these Sections and in accordance with the Manual as part of the League.
- 14.2. The Competition shall be open to all Clubs taking part in the Women's Premier League and Women's National League.
- 14.3. The Council may invite any other Club to participate in this Competition. The Council may also in its absolute discretion reject entry of any Club.
- 14.4. The draw of the Competition shall be done at least one (1) month before the commencement of the preliminary rounds. The first named team in the Match Schedule bracket shall be considered the 'home' team.
- 14.5. The Competition shall be played on a single round-robin group stage basis, followed by a single-leg knockout stage basis. The FAS Competitions Committee shall reserve the right to amend the format of the Competition if necessary.
- 14.6. The winner for the knockout stage Matches up until the final shall be the team that scores the greater number of goals in ninety (90) minutes of regulation time. In the event the scores are tied after ninety (90) minutes of regulation time, the winner shall be decided by Penalties (penalty shoot-out).
- 14.7. For the Final Match, the winner of the Match shall be the team that scores the greater number of goals in ninety (90) minutes of regulation time. In the event the scores are tied after ninety (90) minutes of regulation time, thirty (30) minutes of extra time (two halves of fifteen (15)

minutes each) shall be played. The winner shall be the team that scores the greater number of goals in the thirty (30) minutes of extra time. In the event that the scores are still tied after thirty (30) minutes of extra time, the winner shall be decided by Penalties (penalty shoot-out).

## **SECTION C: TEAM OFFICIAL DELEGATION**

### **15. List of Players**

15.1. All Players playing in the League shall be classified as:

15.1.1. Amateurs

15.2. An amateur Player is defined as one who may be paid his actual expenses involved in playing football, e.g. travelling allowance, etc. Players who have never received remuneration other than for actual expenses incurred during the course of their participation in or for any activity connected with association football shall be regarded as amateur. To this effect, meal allowances, travel and hotel expenses incurred through involvement in a Match and the cost of a Player's equipment, insurance, and training, may be reimbursed without jeopardizing a Player's amateur status.

### **16. Eligibility of Players**

16.1. Each Club shall ensure that all Players:

16.1.1. are duly registered with the FAS pursuant to these Regulations and its transfer regulations.

16.2. A registered Player is one who has been registered and approved by the FAS Competitions Department before playing in any Competition organised and sanctioned by FAS.

16.3. The approval of the registration of a Player by the FAS Competitions Department does not mean that the Player is eligible to participate in the Competition. Each Club is responsible for fielding only eligible Players in a Match. Failure to do so shall lead to the consequences stipulated in Article 17.

16.4. Each Club shall ensure to submit authentic documents for registration of its Players.

16.5. An eligible Player for a particular Match is one who:

- 16.5.1. Is not serving a suspension as a result of a caution/dismissal in a Match; or
- 16.5.2. Is not serving a suspension as a result of an FAS Disciplinary Committee verdict; or
- 16.5.3. Has been fielded in a Match without contravening any of the League's requirement of fielding and/or substitution of Players.

16.6. A Player shall be deemed ineligible, without limitation, if:

- 16.6.1. There is a violation of Article 16.4 or 16.5; or
- 16.6.2. He participates in a Match contrary to a decision of the FAS Disciplinary Committee, these Regulations, or the operation of the FAS Disciplinary Code; or
- 16.6.3. The FAS determines that any document submitted during registration is incorrect, falsified or forged.

### **17. Breach of Conditions of Eligibility**

17.1. Should a Club field an ineligible and/or a suspended Player, or field a registered Player in the starting line-up who has been named as a substitute, or without the Player's name being indicated so either in the starting line-up or as a substitute in accordance with the Player Start List and the procedures in accordance with the Manual, the infringing team may be fined a sum of up to Two Thousand Dollars (SGD\$2,000.00) and/or in addition three (3) points shall be awarded to the opposing non-infringing team, and the score of the Match concerned to remain/or a three (3) – nil (0) shall be awarded to the said non-infringing team, whichever is greater. At the discretion of the FAS Competitions Committee, the infringing Club/Player may be referred to the FAS Disciplinary Committee for further sanctions.



## **18. Registration Windows**

- 18.1. There are two (2) Registration Windows for the League:
  - 18.1.1. First Registration Window – The period starting on 8 February 2024 and ending on 15 March 2024.
  - 18.1.2. Second Registration Window – The period starting on 3 June 2024 and ending on 21 June 2024.
- 18.2. Clubs in the League can change as many of their local and Foreign Players during a Registration Window on any dates decided by the FAS Competitions Department. No change of Players shall be made after the closure of the Registration Window. Without breaching any of the Regulations in these Sections, a Player is eligible to play if he is registered no later than seventy-two (72) hours before the kick-off of the next upcoming Match during the Registration Window.
- 18.3. Clubs failing to meet the minimum registration requirements set by the FAS, at the closure of the minimum registration deadlines and/or after the close of Registration Windows shall constitute a disciplinary offence.
- 18.4. At any time before the commencement of the League, should a Local Transfer Certificate (LTC) request be made by a Club, the LTC shall be approved on MyFAS, or issued by the releasing Club within seven (7) days from the date of request. If the releasing Club is unable to release the LTC, the reason(s) shall be made known in writing to the requesting Club, with a copy to FAS Competitions Department, who shall have the authority to decide on the validity of the reason(s) stated.
- 18.5. When the LTC is not issued within the seven (7) days period, the requesting Club may seek assistance from FAS, at its absolute discretion, may issue a LTC for the Player concerned on behalf of the releasing Club.
- 18.6. During the ongoing League, a Player shall be allowed to be transferred and registered to another Club within the same Season.
- 18.7. Pursuant to Article 18.6 above, a Player shall only be registered with a maximum of two (2) Clubs in the Season.
- 18.8. Upon request of the International Transfer Certificate (ITC) of a Player (Foreign or local), provided all other registration documents are in order and no League Regulations are being breached, provisional registration may be granted by Director, Competitions, for the Player concerned pending the arrival of the ITC. The Player concerned shall only be eligible to play when the ITC is received by FAS.

## **19. Stages of Registration of Players**

- 19.1. There are three (3) stages of registration for the Players in the League:
  - 19.1.1. Preliminary Registration (Minimum Registration Deadline);
  - 19.1.2. Player Selection List in accordance with these Regulations;
  - 19.1.3. Player Start List in accordance with these Regulations.
- 19.2. Should the FAS Competitions Department not receive all required documents by the stipulated deadlines for Registration Windows the Club concerned shall be considered to have withdrawn from the Competition prior to its commencement and be subject to Article 7.
- 19.3. In the event of a Player registering for more than one (1) Club, priority of registration shall be the deciding factor. The Club submitting the later registration shall be notified of the prior

registration of the said Player, and the FAS, shall investigate the circumstances under which the registrations were conducted.

- 19.4. Any Player found to have wilfully registered with more than one (1) Club or a Club found to have knowingly induced a registered Player of another Club to register will be considered as gross misconduct and shall be dealt with by the FAS.
- 19.5. Players who have been de-registered or have his contract terminated by a Club during the Season, shall be allowed to move to another Club during the next available registration window provided it does not contravene any of the Regulations.
- 19.6. In extenuating circumstances, the FAS can approve Players to move to another Club before the next available registration window.

## **20. Squad Composition**

- 20.1. All Clubs shall have a minimum squad of eighteen (18) Players, as at the pre-season minimum registration deadline and a maximum of twenty-five (25) Players. A minimum of two (2) goalkeepers shall be registered.
- 20.2. Players shall be sixteen (16) years of age and above at the point of registration.
- 20.3. Players under the age of sixteen (16) shall only be eligible for registration after undergoing and passing the mandatory technical assessment set by the FAS Technical Division. This includes Players who have been assessed in previous Seasons.
- 20.4. All Clubs may register a maximum of four (4) Foreign Players with a minimum age of sixteen (16) years of age and above at the point of registration.
- 20.5. These Foreign Players shall either be working (does not include professional footballers), studying or legally residing in Singapore and possess a valid Work Permit (WP), Skilled Workers Pass (SP), Employment Pass (EP), Student Pass, Dependent's Pass or Singapore Permanent Residency status.
- 20.6. Permanent Residents shall be considered Foreign Players.
- 20.7. No Foreign Player can be registered with the FAS until his International Transfer Certificate (ITC) has been received by the FAS and submitted together with other relevant and required supporting documents as stipulated by FAS Competitions Department. Clubs intending to register Foreign Players shall seek prior approval in writing from Director, Competitions.

## **21. Documents for Registration of Players**

- 21.1. Players shall be registered via MyFAS with the supporting documents issued by the FAS.

## **22. Breach of Conditions of Registration**

- 22.1. Should a Club field an unregistered Player, the Club shall be expelled from the League and any further participation in the League, in accordance with Article 7 and its sub-articles.

## **23. Execution of Memorandum of Understanding (MOU)**

- 23.1. All Players registered to play in the League shall execute an MOU with the Club they are registered with.
- 23.2. MOUs involving Players under the age of twenty-one (21) shall be signed together by either of the Player's parent or guardian.

**24. Conditions of Memorandum of Understanding (MOU)**

- 24.1. All MOUs between Clubs and Players shall be in the official template issued by FAS. The MOUs shall be signed on behalf of the Club by an authorized Club Official. The main body of the MOU in its official form shall not be amended without leave of Director, Competitions.
- 24.2. All Clubs shall submit copies of all MOUs to the FAS Competitions Department via MyFAS.
- 24.3. When a Player's MOU is terminated by mutual consent, the Club may retain the Player's registration until he signs for another Club.
- 24.4. All termination of MOUs between Club and Player shall be of mutual consent and not unilaterally by either party. The Club shall submit to the FAS a copy of the mutual termination of the MOU for FAS' official record.

**25. Registration of Team Officials**

- 25.1. Each Club shall submit to FAS via MyFAS its registration of Team Officials and the supporting documents in accordance with these Regulations.
- 25.2. Except with the prior written consent of FAS, no person, by himself or with one (1) or more associates, shall at one time, either directly or indirectly, be involved in any capacity whatsoever in the management or administration of more than one (1) Club.
- 25.3. All Clubs may register a minimum of two (2) and a maximum of ten (10) Team Officials.
- 25.4. Up to seven (7) Team officials may be registered for each Match to be on the Substitutes Bench. The following two (2) Team Officials shall be present for all Matches:
  - 1. A Head Coach
  - 2. A Sports Trainer
- 25.5. All Clubs shall ensure that the following positions adhere to the following requirements stipulated below:

| Position       | Requirements                                      |
|----------------|---|
| Head Coach     | Valid AFC 'B' License Certification or equivalent |
| Sports Trainer | Valid First Aid Certification                     |

- 25.6. Should a Head Coach not possess the minimum coaching qualification, the Club can apply for an official Recognition of Experience and Coaching Competence (RECC) through the FAS Technical Department. The approval of RECC shall be at the discretion of the FAS Technical Department and shall be only valid for one (1) year.
- 25.7. The Head Coach shall be present for all the Matches where he is in-charge, unless approval has been sought and given by the FAS Competitions Department, for the Head Coach to do otherwise.
- 25.8. In the event that a Club terminates the Head Coach's services, or he resigns during the Season, the Club is bound to notify the FAS in within seven (7) days and find a replacement with the required minimum coaching qualification within sixty (60) days. However, in the event that there is not more than sixty (60) days left from the material date of the termination or resignation to the end of the Season, the Club may appoint, subject to the approval of the Director, Competitions, an acting/interim Head Coach not meeting the required coaching qualifications.
- 25.9. Any Club found to be in breach of Articles 25.1 to 25.8 above shall be deemed to be guilty of misconduct.

## **26. Team Official Delegation**

- 26.1. A team shall receive a set of endorsed Accreditation Pass List from the FAS Competitions Department for all registered and approved Players and Team Officials for the Competition.
- 26.2. Pursuant to the above, all registered and approved Team Officials shall be issued with Accreditation Cards authorized by the FAS Competitions Department.
- 26.3. Should the Accreditation Pass List be misplaced, the Club shall be required to pay One Hundred Dollars (SGD\$100.00) as a replacement production fee for the document.
- 26.4. Should an Accreditation Card be misplaced, the Club shall be required to pay One Hundred Dollars (SGD\$100.00) as a replacement production fee for each Accreditation Card.
- 26.5. For each Match in the League, Clubs shall register a Team Official Delegation comprising of maximum twenty (20) Players and seven (7) Team Officials.

## **27. Cancellation of Registration**

- 27.1. The registration of a Player may only be terminated during the playing Season as follows:
  - 27.1.1. Mutual termination of the MOU between a Player and the Club;
  - 27.1.2. In writing by the Club; and
  - 27.1.3. As decided by the FAS Competitions Department.
- 27.2. The registration of a Player, local or Foreign, released or terminated by his Club and by the Competitions Department the latter being satisfied of the same, shall be cancelled.
- 27.3. The Club shall notify the FAS Competitions Department immediately in writing, accompanied by the supporting or relevant documents related to the termination when the registration of such a Player is cancelled by the Club for any reason whatsoever.
- 27.4. Any Club found to have infringed Article 27.3 shall be deemed to be guilty of misconduct.

## **28. Temporary Registrations**

- 28.1. It is at the absolute discretion of the Director, Competitions to allow, in extenuating circumstances, the additional registration (or registrations) of a goalkeeper (or goalkeepers) outside of the prescribed Player Registration Windows, the quota of Players being maintained by the Club in reference as per these Regulations.
- 28.2. The FAS Competitions Department shall not allow a Club to sign a goalkeeper on temporary transfer for a period less than one month (30 days), unless in exceptional circumstances, and with the consent of the Director, Competitions, and as per these Regulations.

## **29. Inducements and Approaches**

- 29.1. Clubs, Officials or Players shall not directly or indirectly attempt to induce a Registered Player of another Club to leave for any purpose whatsoever the Club with which he is registered. Any infringement of this Rule shall be deemed to be misconduct and shall be dealt with by the FAS Competitions Department in its absolute discretion, which shall (but not limited to) be entitled to take such action/or impose such penalties against the Official or Player or the Club as they may in the circumstances think fit. Any penalty imposed on a Club may include the refusal to register for the Club guilty of the infringement, any Player who they consider has been so induced.
- 29.2. All transfers of registration shall be arranged directly between the Clubs concerned and the Player. No Club shall register a Player who is on the list of registered Players of another Club or who has failed to comply with a decision of the Competitions Committee or the Players' Status Committee, adjudicated on an appeal made under these Regulations.

Infringements of this rule shall also be dealt with by the Competitions Committee which may impose any penalty, at its absolute discretion, as it feels necessary, including a refusal to register the Player.

- 29.3. A registered Player shall not directly or indirectly communicate with or approach another Club or any Official or Player of another Club with the object of negotiating or arranging the transfer of himself or another Club another Player to such other Club. Any infringement of this rule shall render the Player concerned and any Official or other Player who enters into communication or negotiation with him liable to such penalties by way of fine, suspension, expulsion or otherwise as the Competitions Committee may deem fit in the circumstances.

### **30. Players Transferred from One Club to Another**

- 30.1. A Club wishing to engage the services of a Player who is at present under a MOU with another Club shall, before commencing any negotiations with the Player, be obliged to inform his Club in writing of its interest and obtain official permission to begin negotiations.

### **31. Final Provisions**

- 31.1. Any matter not provided for under these Regulations in this Section shall be settled by the PSC and shall not be subject to appeal.
- 31.2. The PSC reserves all rights to alter, revoke, add or vary these Regulations from time to time at their absolute discretion.

## **SECTION D: TECHNICAL REGULATIONS**

### **32. Duration of Matches**

- 32.1. All League Matches shall last ninety (90) minutes, comprising two (2) periods of forty-five (45) minute, with a half-time interval of fifteen (15) minutes.
- 32.2. The half-time interval shall not exceed fifteen (15) minutes, from whistle to whistle.

### **33. Technical Area**

- 33.1. The technical area shall be considered as extending one (1) meter on either side of the designated seated area and shall extend forward up to a distance of one (1) meter away from the touchline.
- 33.2. The occupants of the technical area shall be identified by the Fourth Official and/or the Match Commissioner before the commencement of the Match.
- 33.3. Accreditation Cards shall be worn by all registered Team Officials at all times. Any Team Official in the technical area found guilty of not wearing an Accreditation Card shall be fined a minimum sum of Two Hundred Dollars (SGD\$200.00).
- 33.4. No Player who has been given the red card (or any suspended Player or Official) shall be permitted to sit in the technical area or be allowed to be in the vicinity of the Field of Play.
- 33.5. Only one (1) Official in the technical area at a time has the authority to convey tactical instructions.
- 33.6. The coach and other Team Officials shall remain within the confines of the technical area except in special circumstances, for example, a doctor and/or a physiotherapist and/or a Sports Trainer or a first aid nurse(s) can enter the Field of Play with the Referee's permission to treat an injured Player.
- 33.7. The coach and other occupants of the technical area shall always conduct themselves in a responsible manner.
- 33.8. Only a maximum of seven (7) registered Team Officials and nine (9) substitute Players are allowed to be on the Substitutes' Bench.

### **34. Footballs**

- 34.1. The footballs for the Competition shall be selected and supplied by FAS.
- 34.2. Each Club shall receive twenty (20) Match Balls prior to commencement of the Competition.
- 34.3. The home team of every Match shall provide a minimum of three (3) Match Balls supplied by FAS.

### **35. Player Selection List**

- 35.1. For all Matches, each Club shall receive a 'Player Selection List' on which the jersey numbers and names of the Players are listed, minimum two (2) days prior to the Match.
- 35.2. All Clubs shall provide one (1) duly completed 'Player Selection List' to the Match Commissioner no later than twenty (20) minutes prior to the scheduled kick-off. The Club shall indicate on the starting list the eleven (11) Players who shall start the Match and the other nine (9) named substitutes. The Team Captain shall also be identified on the starting list. The Club is liable for disciplinary action for failure to submit the Player Selection List on time.

- 35.3. Before a 'Player Start List' is made Official fifteen (15) minutes prior to the scheduled kick-off, should a starting Player named in the starting eleven (11) not be physically present for the pre-match inspection by the Match Commissioner, the Player shall not be allowed to be included in the starting eleven (11). The Club shall be required to remove the Player from the starting list and replace him with a Player who is physically present, either from any of the named substitutes or list of 'not playing' Players indicated in the original 'Player Selection List' submission.
- 35.4. Pursuant to Article 35.3, should a Club not have eleven (11) Players physically present for the pre-match inspection by the Match Commissioner, the Match shall proceed and the relevant clauses in Article 46 shall apply.
- 35.5. Pursuant to Article 35.3, should a Club not have a minimum of seven (7) Players physically present at the point of kick-off, the relevant clauses in Article 47 shall apply.
- 35.6. Once the Match Commissioner has produced the Player Start List, as an official document signed by both teams and the Match Commissioner, and if the Match has not yet kicked-off, the following instructions apply:
- 35.6.1. If any of the eleven (11) Players listed on the Player Start List selected to start the Match are not able to start the Match for any reason, they may be replaced by any of the named substitutes. Such replacements shall reduce the quota of substitute Players accordingly. The Player being replaced cannot be renamed as a substitute. During the Match, seven (7) substitutions may still be made by the Club.
- 35.6.2. If any of the substitutes named on the Player Start List is not able to be fielded for any reason, they may not be replaced, which means that the quota of substitute Players shall be reduced accordingly.
- 35.7. Any Club failing to carry out these provisions shall be fined a sum of One Thousand Dollars (SGD\$1,000.00) for the first offence, Two Thousand Dollars (SGD\$2,000.00) for the second offence and for any subsequent offence shall be deemed guilty of misconduct and may be referred to the FAS Disciplinary Committee.

### **36. Substitution of Players**

- 36.1. In all Matches, each Club is permitted a maximum of seven (7) named substitutions.
- 36.2. There shall be no substitution of any Player who is ordered off the Field of Play.
- 36.3. Should a Club be found to infringe any of the Regulations above in relation to substitution of Players, the Match and three (3) points shall be awarded to the opposing non-infringing team, and the score to remain or a three (3) - nil (0) win to be awarded to the said non-infringing team, whichever is the greater. If a Match is forfeited, suspension is only considered to have been served if the team to which the suspended Player belongs is not responsible for the facts that led to the forfeit of the Match. The Club may also be liable to further disciplinary sanctions.

### **37. Player Identification**

- 37.1. The Players' jerseys shall be clearly numbered on the back in accordance with the registration of Players and with the Player Selection List submitted to the Match Commissioner before the Match. The registration of Players' numbers and its conditions are:
- 37.1.1. Each Player shall be allocated a different number from numbers 1 to 99.
- 37.1.2. A Player's number shall remain with him for the duration of the League unless either:
- 37.1.2.1. He ceases to play for the Club; or
- 37.1.2.2. For other reasons that are deemed satisfactory to the FAS Competitions Department as per the Regulations

- 37.2. Pursuant to the above, any Club which fields a Player in a Match wearing a jersey not carrying the number allocated to him shall be fined a minimum sum of Five Hundred Dollars (SGD\$500.00).
- 37.3. The Match Commissioner shall, during the stipulated time for Player checks on the Official Match Countdown, check the Accreditation Pass List of the Players named in the Player Selection List to ensure that it is in order, and that the Player is eligible to play.
- 37.4. Pursuant to the above, if a Club fails to produce the Accreditation Pass List of the Players during the Player checks or by the stipulated kick-off timing, the Match Commissioner will not proceed with the Player checks and the Club shall be fined a minimum sum of One Thousand Dollars (SGD\$1000.00) and in addition a three (3) – nil (0) shall be awarded to the said non-infringing team.
- 37.5. Notwithstanding the fines herein this sub-Section, the Director, Competitions, may take such other action as it deems desirable against the Club, its Official, or the Player for any infringement of these provisions or refer the matter to the FAS Disciplinary Committee.

### **38. Club Protest**

- 38.1. Any Club intending to lodge a protest against their opponents for any violation of the Competition procedure in or about the Match shall do so in writing signed by the General/Club Manager or Hon. Secretary of the Club or a responsible Official of the Club to the FAS Competitions Department within forty-eight (48) hours from the end of the Match with a deposit of One Thousand Dollars (SGD\$1,000.00).
- 38.2. Pursuant to article 38.1 above, any protest(s)/complaints lodged by Clubs without meeting the conditions stipulated in article 38.5 below, shall not be entertained by the FAS Competitions Department.
- 38.3. No protest shall be lodged relating to the Referee's decisions regarding facts connected with play. Such decisions are final and binding and not subject to appeal.
- 38.4. In cases where a decision by the Referee involves an obvious error (such as mistaking the identity of the person penalized), the FAS Committee and/or judicial bodies may only review the disciplinary consequences of that decision. In cases of mistaken identity, the relevant proceedings may be opened against the person who was actually at fault.
- 38.5. Any Club intending to lodge a protest against the Referee's decision at a Match shall abide by the following procedure:
  - 38.5.1. The Team Manager or a responsible Official of the Club shall notify the Match Commissioner immediately after the relevant Match that he shall be filing an Official protest. The Match Commissioner shall reflect this in his report and submit a detailed report on the incident.
  - 38.5.2. The Team Manager/Official shall then send in a full written report (including the appropriate Protest Form issued by the FAS General Secretariat) of his Official protest to the FAS Competitions Department within forty-eight (48) hours, following the end of the relevant Match, accompanied by a fee of One Thousand Dollars (SGD\$1,000.00).
  - 38.5.3. On receiving the protest, the Director, Competitions, after studying the relevant reports, shall decide on the outcome where possible.
  - 38.5.4. When no decision can be ascertained, the FAS Referees' Department and/or FAS Committees may be consulted.
  - 38.5.5. The Player pending the appeal shall have to serve his mandatory suspension until a decision is arrived at by the Director, Competitions.
  - 38.5.6. All decisions pertaining to the protest shall be binding and final.
  - 38.5.7. Where the Referee's decision is upheld, the Director, Competitions, shall decide whether the Club shall have to forfeit the One Thousand Dollars (SGD\$1,000.00) imposed on the Club and where the Referee's decision is overruled, the One Thousand Dollars (SGD\$1,000.00) deposit may be refunded to the Club.



38.6. The FAS Committee and/or judicial bodies are also responsible for:

- 38.6.1. sanctioning serious infringements which have escaped the Match Official's attention; and
- 38.6.2. rectifying obvious errors in the Referee's disciplinary decisions.

## **SECTION E: DISCIPLINARY**

### **39. Disciplinary Measures**

- 39.1. All disciplinary measures in relation to the League shall be undertaken in accordance with these Regulations, FAS Constitution, FAS Disciplinary and Ethics Code, and any relevant FAS circular.
- 39.2. The FAS may introduce new disciplinary regulations and sanctions for the duration of the League. Such regulations shall be communicated to the Clubs in due course.
- 39.3. Only Players and Team Officials may serve Match suspensions in the League. For avoidance of doubt, this requires the registration of the relevant individual within a Registration Window in accordance with the deadlines set out in these Regulations.
- 39.4. All Players agree to:
  - 39.4.1. respect the spirit of fair play, respect, proper conduct, non-violence, and the authority of the Match Officials;
  - 39.4.2. behave accordingly; and
  - 39.4.3. refrain from doping.

### **40. Administrative Procedure**

- 40.1. Where a specified financial penalty and/or sanction is/are provided for in these Regulations in these Sections, the Exco shall have, through the Director, Competitions or any of the Standing Committees, the full power to impose against any Club, Official and/or Player and/or Member who they shall deem guilty of having offended against or committed a breach of these Regulations in these Sections such financial penalties and/or sanctions as these Regulations hereinafter appearing permit.
- 40.2. The FAS Congress shall elect a Committee known as the FAS Disciplinary Committee (hereinafter "the Committee").
- 40.3. The Committee shall receive from the Director, Competitions, or any Standing Committee of the FAS or the Exco itself notice of any suspected or alleged offence or breach of any of these Regulations of these Sections or any misconduct notwithstanding that a penalty for such offence, breach of the Regulations under these Sections or misconduct is not specifically provided for by the Regulations.
- 40.4. The Exco delegates the exercise of any of its powers under these Regulations either generally or specifically to the Committee or the Director, Competitions, or any of the Standing Committees of the FAS or the FAS PSC for adjudication and determination as hereunder set out.
- 40.5. The Committee pursuant to these Regulations shall consist of a maximum of twelve (12) members, of whom any three (3) shall be adequate to hear and determine any matter. From among the three (3), one (1) shall be the Chairperson of the Committee. The Chairman of the Committee has the power to appoint a Deputy Chairman or any member of his Committee who shall deputise as Chairman as and when necessary.
- 40.6. The Committee shall draw its own sub-rules which may include procedures, infringements and sanctions, implementation thereof, and any appeal procedures or powers thereof, including such order as to the payment of expenses, costs or financial penalties by Clubs, Players or Officials or Members of the Club as they think fit, in accordance with the FAS Disciplinary and Ethics Code.
- 40.7. The Committee shall have the power of inquiry into all disputes, questions or differences between Clubs and Players, Officials or Members of the Club, and into all matters constituting or pertaining to any breach of these Regulations under the various Sections by

Clubs, Players, Officials and Members of the Club as may be referred to by the Director, Competitions or any of the FAS's Standing Committees, and to convene a hearing on notice being given, and to effect that purpose the Committee may require the attendance of all Officials, Players and other persons for the hearing of the complaint and compel the production of all books, letters and other documents relevant and necessary for the determination of the dispute/question/difference.

- 40.8. Any Club, Official, Player or Member of the Club offering or receiving a payment or any other form of inducement to or from any Club or Official or Player or Member of any Club or any person, or any such Club, Official or Player or Member receiving or seeking to receive any payment or any other form of inducement from any other person or organisation to win, lose or draw a Match under the jurisdiction of the FAS shall be deemed guilty of misconduct. The FAS or any of its Standing Committees or the Director, Competitions shall have the power to refer such acts to the relevant authorities.
- 40.9. The Committee or such other Standing Committee of the FAS, inclusive of the Director, Competitions, the Arbitrator or Board of Arbitrators or the Appeals Committee or the PSC, shall be entitled to publish in the media or in such other manner as they shall think fit reports of their proceedings, acts, resolutions, findings and financial penalties whether the same shall or shall not reflect on the character or conduct of any Club, Official, Player or Member, and every such Club, Official, Player or Member shall be deemed to have assented to such an inquiry and such publication.

#### **41. Differences between Clubs**

- 41.1. A Club in the first instance shall refer all differences and questions or disputes between it and any other Club or Officials or Players or Members thereof to the Director, Competitions. Each Club making such a reference shall do so in writing and shall deposit a fee of Three Thousand Dollars (SGD\$3,000.00) only which shall be liable to be forfeited to the FAS at the discretion of the Committee or the Director, Competitions or Arbitrator or the FAS three (3) Arbitrators or such Standing Committee or the PSC as the case may be.
- 41.2. On any such submission or reference, the Director, Competitions, may in his absolute discretion:
- 41.2.1. either determine the dispute, question or difference himself; or
  - 41.2.2. refer to or delegate the determination of such dispute, difference or question, at the absolute discretion of the Director, Competitions, to a single Arbitrator or a Board of three (3) Arbitrators appointed by the Director, Competitions or to any of the Standing Committees of the FAS or the PSC; or
  - 41.2.3. refer the matter to the Committee.
- 41.3. The Director, Competitions shall be under no obligation whatsoever to grant an oral hearing to a Club should he, in his absolute discretion, refer the matter to a single Arbitrator or a Board of three (3) Arbitrators or the Committee or any of the Standing Committees of the FAS or the PSC.
- 41.4. Any Club aggrieved at the determination of the Director, Competitions or the Arbitrator or the Board of three (3) Arbitrators or of the Committee or any of the Standing Committees of the FAS, made pursuant to this Rule as regards the determination of the dispute, question, difference, or at the manner in which such determination was arrived at, shall refer the matter to the Appeal Committee [hereinafter "the Appeal Committee"] as provided in this Section, and any decision of the Appeal Committee shall be final and binding on all parties.
- 41.5. Membership for the time being for the FAS shall constitute an agreement to refer all disputes, questions and differences between the Director, Competitions who shall determine the same in accordance with the provision of Article 41.2 above.
- 41.5.1. The Arbitration tribunal ("the tribunal") shall consist of either a single Arbitrator or three (3) Arbitrators appointed by the Director, Competitions. The Director, Competitions, in

- a case involving three (3) Arbitrators, appoint a Chairman to chair all such meetings, and three (3) members shall hear the matter, adjudicate, and determine the dispute, question or difference.
- 41.5.2. If any arbitrator appointed by the Director, Competitions shall die, refuse to act, or become incapacitated from acting prior to the making of a determination a further arbitrator shall be appointed by the Director, Competitions to replace him.
- 41.6. As soon as practicable after it has been convened, the Arbitrator or Board of three (3) Arbitrators or such Standing Committee of the FAS or the PSC as the case may shall convene a meeting with the parties or their representatives. The Arbitrator or Board of three (3) Arbitrators or such Standing Committee of the FAS or the PSC may adopt such procedures as it considers appropriate for the resolution of the dispute, question, or difference, and may proceed by way of oral hearing or by written submission, and by such manner of evidence as it considers appropriate.
- 41.7. Any decision or procedural decision shall be made by the Arbitrator himself or in the case of the Board of Arbitrators or such Standing Committee or the PSC shall, where necessary, be made by a majority and, in the event that no majority may be formed, the Chairman of the Board of Arbitrators or the Chairman of such Standing Committee or the PSC shall make his determination as if he were a sole arbitrator.
- 41.8. No party shall be represented at any hearing by a solicitor or counsel acting in his capacity as such, unless he has been a member of a Club for a period of at least twelve (12) months preceding the appointment of the Arbitrator, Board of Arbitrators or such Standing Committee or the Committee or the PSC or the Appeal Committee to hear the dispute, question or difference or any appeal therefrom.
- 41.9. In the event of default by either party in respect of any procedural order of the Arbitrator or Board of three (3) Arbitrators or such Standing Committee or the Committee or the PSC, the Arbitrator or such Board or such Standing Committee or the Committee or the PSC shall have the power to debar that party from further participation in the arbitration/ proceedings, and deliver its determination as the Arbitrator or such Board or such Standing Committee or the Committee or the PSC may deem fit.
- 41.10. The power of the Director, Competitions, the Arbitrator or the Board of three (3) Arbitrators or such Standing Committee or the Committee or the PSC to forfeit the deposit under Article 41.1 shall be in addition to the power conferred on the Director, Competitions, the Arbitrator or the Board of three (3) Arbitrators or such Standing Committee or the Committee or the PSC to determine the difference, dispute or question. Any form of misconduct during the conduct of the proceedings found by the Director, Competitions or the Arbitrator or the Board of Arbitrators or such Standing Committee or the Committee or the PSC or the Appeal Committee may be referred to the Exco.

## **42. Procedure and Appeals**

- 42.1. The Director, Competitions, the Arbitrator or the Board of Arbitrators or the Committee or any of the Standing Committees of the FAS (save for the PSC) imposing any decision or penalty on any Club, Player or Official or Member shall inform in writing any Club or person against whom action is being taken of any such decision as soon as practicable thereafter.
- 42.2. Any Club or person against whom action is being taken (save for the decision of the PSC) may, within seven (7) working days of being informed of such a decision, require the body or person taking such action to specify in writing the findings of fact leading to the decision and the reasons for the decision. A fee of One Thousand Dollars (SGD\$1,000.00) shall accompany such request. Any such requirement shall be met within seven (7) working days of its receipt and shall be accompanied by copies of all materials which were before the body or person making the decision, or such of that material as such body or person may consider relevant to the decision.

- 42.3. Any Club or person on whom a decision and/or penalty has been imposed pursuant to these Regulations may appeal against such decision and/or against the penalty so imposed. Any such appeal shall be made and conducted in accordance with the provisions of this Rule.
- 42.4. A notice of appeal shall be in writing and shall be lodged with Director, Competitions with a copy to the Secretary of the Appeal Committee within seven (7) working days of the receipt of the decision, or where a request for the reasons for the decision has been made within seven (7) working days of the receipt of those reasons and shall be accompanied by a deposit of Three Thousand Dollars (SGD\$3,000.00). This amount may be refunded to the appellant if the appeal is successful.
- 42.5. At the same time that the notice of appeal is lodged there shall also be lodged with the Director, Competitions with a copy to the Secretary of the Appeal Committee:
  - 42.5.1. a statement of the grounds of appeal; and
  - 42.5.2. if leave is sought to present any fresh evidence to the Appeal Committee, particulars of such evidence and of the reasons why it was not presented to the earlier decision-maker, and
  - 42.5.3. particulars of any fact or circumstances which do not appear from the statement or accompanying documents upon which the appellant is seeking to rely.
- 42.6. The Appeal Committee shall be elected by the FAS Congress. No persons so appointed shall have taken part in any previous proceedings relating to the same matter. The decision of the Appeal Committee shall be final and binding on all parties concerned.
- 42.7. Upon the application of either party, or of its own motion, the Appeal Committee may hold preliminary hearings for the purpose of:
  - 42.7.1. deciding any application for leave to call fresh evidence;
  - 42.7.2. giving any other instructions which it considers necessary for the conduct of the proceedings; and the Appeal Committee may at any time extend or abridge all or any time limits governing appeals and may permit amendments to documents lodged by the parties on such terms as it thinks fit.
- 42.8. No fresh evidence shall be presented to the Appeal Committee without its leave. Save in the exceptional circumstances, no such leave shall be given unless:
  - 42.8.1. the evidence was not available at the time of the hearing appealed against despite the exercise of reasonable diligence;
  - 42.8.2. it is credible evidence; and
  - 42.8.3. it is relevant.
- 42.9. An appeal shall be by way of re-hearing on the documents, except where the Appeal Committee gives leave to present fresh evidence and save that the parties shall be entitled to make oral representations to the Appeal Committee at the hearing. Subject to Article 42.8 above, no party may be represented at the hearing of any appeal by solicitor or counsel acting in his capacity as such.
- 42.10. The Appeal Committee, like the PSC, may conduct the hearing in such a manner and at such times as it considers desirable and/or suitable. If either party fails to attend at the hearing, the Appeal Committee, like the PSC, may proceed in its absence. The Appeal Committee and/or the PSC shall not be bound by any enactment or rule of law relating to the inadmissibility of evidence in proceedings before any court of law.
- 42.11. An Appeal Committee shall have power:
  - 42.11.1. to allow or dismiss the appeal;
  - 42.11.2. to vary the decision and/or penalty in such a manner as it shall think fit, including the power to increase, decrease or remit any penalty included in such decision except when

- such penalty shall be specified in these Regulations when the Appeal Committee shall impose such penalty if it finds the case proved;
- 42.11.3. to remit the matter with such directions as it thinks fit for re-hearing and determination by the earlier decision making body;
  - 42.11.4. to make such further or other order as it thinks fit, including an order to forfeit the deposit.
- 42.12. An Appeal Committee shall not be bound to allow an appeal on the ground of misdirection or wrong evaluation of evidence, unless in the opinion of the said Committee, substantial injustice, including a miscarriage of justice, has thereby been occasioned.
- 42.13. An Appeal Committee may take account of facts or matters which have become evident or have occurred since the date of the decision appealed against where, pursuant to leave given to call fresh evidence, evidence has been given about such matters.
- 42.14. Where an Appeal Committee dismisses an appeal or varies the decision, the Appeal Committee may order the deposit to be forfeited towards the costs of the appeal and may make any further order for the payment of costs.

#### **43. Powers of the Director, Competitions, the Arbitrator or Board of Arbitrators or the Committee or Standing Committee of the FAS**

- 43.1. Upon finding an offence, or a breach of these Regulations or if misconduct is proved, the Director, Competitions, the Arbitrator, the Board of Arbitrators or the Committee or any such Standing Committee of FAS or the PSC shall be entitled to take such action and to impose such penalties by way of reprimand, fine, suspension, deduction of points, or other penalty (or combinations thereof) as the Director, Competitions, the Arbitrator, the Board of Arbitrators or the Committee or any such Standing Committee or the PSC may think fit in the circumstances.
- 43.2. The Committee or such Standing Committee of the FAS shall only be entitled to recommend expulsion of a Club to the Exco, and such power shall also avail to the Appeal Committee, but no Club shall be expelled from the League without the sanction of a resolution passed at a Meeting of the Exco of the FAS. There shall be no right of appeal against a resolution to expel, passed as aforesaid, by the Exco.
- 43.3. The Director, Competitions, Arbitrator, Board of Arbitrators or the Committee or the Standing Committees of the FAS or the PSC shall be entitled to order any Club, Player, Official or Member for any such offence against or breach of these Regulations of these Sections or misconduct, and, where applicable, cancel or refuse registrations of Players which are contrary to these Regulations or Regulations laid down by any of the Standing Committees of the FAS.

#### **44. Sanctions / Penalties**

- 44.1. Disciplinary sanctions and penalties which may be imposed by the Exco, the Committee, any of the Standing Committees of the FAS, or the Arbitrator or Board of three (3) Arbitrators or the PSC or the Appeal Board on Players, Clubs, Officials and Members of the Clubs shall include:
- 44.1.1. a caution;
  - 44.1.2. a censure;
  - 44.1.3. a fine;
  - 44.1.4. suspension for a specified number of Matches and/or a specified period;
  - 44.1.5. a ban on participating or being involved in a game in any capacity whatsoever;
  - 44.1.6. cancellation of a Match (requiring a replay, if any);
  - 44.1.7. deduction or cancellation of points;
  - 44.1.8. a win by default, in which case a score of three (3)-nil (0) shall be given, unless the goal difference attained in the Match is greater in favour of the non-infringing Club;
  - 44.1.9. a ban from the stadium/stadia or on terms;
  - 44.1.10. Matches to be played with the exclusion of the public or on certain conditions;

- 44.1.11. a ban from taking part in the current and/or future Competition or any part thereof;
- 44.1.12. a cancellation/refusal of registration of a Player or on terms;
- 44.1.13. withdrawal of any or all financial privileges given by the FAS or on terms.

44.2. In determining any disciplinary sanction or penalty to be imposed, the FAS, the Committee or any of the Standing Committees of the Board, or the Arbitrator or Board of Arbitrators or the PSC, and the Appeal Board may be guided by the list of disciplinary measures as specified in the regulations of the FIFA and/or AFC Disciplinary and Ethics Code and/or FAS Disciplinary and Ethics Code.

## 45. Competition Specific Sanctions and Penalties

### 45.1. Match Caution, Dismissal and Accumulation

45.1.1. A Player who is sent off for any of the sending-off offences stated under Law 12 in the Laws of The Game shall be suspended as stipulated below and may also be referred to the Disciplinary Committee, who may after due inquiry impose sanctions and/or penalties over and above the mandatory sanctions and/or penalties on him:

45.1.2. A Team Official who is sent off for any of the sending-off offences stated under Law 12 in the Laws of The Game shall be suspended as stipulated below and may also be referred to the Disciplinary Committee, who may after due inquiry impose sanctions and/or penalties over and above the mandatory sanctions and/or penalties on him:

- 45.1.3. Subject to the provisions of Article 45.1.1 above, a Player who has accumulated two (2) red cards in the course of the League shall be fined Five Hundred Dollars (\$500.00) and/or referred to the Disciplinary Committee, who may after due inquiry impose sanctions and/or penalties over and above the mandatory sanctions and/or penalties on him. In the event the said Player fails or is unable to pay the composition fine within the next seven (7) days, the said Player shall be referred to the Disciplinary Committee. Until then, the said Player shall not be allowed to play in the Competition until he has served the suspension imposed by the Disciplinary Committee, who may after due inquiry impose other sanctions and/or penalties over and above the mandatory penalties.
- 45.1.4. Subject to the provisions of Article 45.1.1 above, a Player who has accumulated three (3) red cards in the course of the League shall be fined One Thousand Dollars (\$1,000.00) and/or referred to the Disciplinary Committee, who may after due inquiry impose sanctions and/or penalties over and above the mandatory sanctions and/or penalties on him. In the event the said Player fails or is unable to pay the composition fine within the next seven (7) days, the said Player shall be referred to the Disciplinary Committee. Until then, the said Player shall not be allowed to play in the Competition until he has served the suspension imposed by the Disciplinary Committee, who may after due inquiry impose other sanctions and/or penalties over and above the mandatory penalties.
- 45.1.5. A Team Official who has accumulated two (2) red cards in the course of the League shall be fined One Thousand Dollars (SGD\$1,000.00) or referred to the Disciplinary Committee, who may after due inquiry impose sanctions and/or penalties over and above the mandatory sanctions and/or penalties on him.
- 45.1.6. A Player who has received three (3) yellow card cautions in the course of the League shall automatically be suspended for the following one (1) Match in the said Competition. If the Player receives a further two (2) yellow card cautions in the course of the same League, he shall automatically be suspended for the following one (1) Match in that Competition. If he receives a further one (1) yellow card caution in the course of the same Competition, he shall be suspended for the following one (1) Match in the said League and shall be fined Five Hundred Dollars (\$500.00) or referred to the Disciplinary Committee, who may after due inquiry impose sanctions and/or penalties over and above the mandatory sanctions and/or penalties on him. In the event the said Player fails or is unable to pay the composition fine within the next seven (7) days, the said Player shall be referred to the Disciplinary Committee. Until then, the said Player shall not be allowed to play in the Competition until he has served the suspension imposed by the Disciplinary Committee, who may after due inquiry impose other sanctions and/or penalties over and above the mandatory penalties.
- 45.1.7. A Team Official who has received two (2) yellow card cautions in the course of the League shall automatically be suspended for the following one (1) Match in the said Competition.
- 45.1.8. A Player who has received two (2) yellow card cautions in the course of the Women's Challenge Cup Competition shall automatically be suspended for the following one (1)



- Match in the said Competition. This shall apply to all stages of the Competition and shall be carried forward until the Final.
- 45.1.9. Notwithstanding Article 45.1.1, the Director, Competitions or any of the Standing Committees of the FAS (including the Committee) or the Arbitrator of the Board of Arbitrators or the PSC or the Appeals Committee may refer to the Committee (and the Committee itself may consider) any misconduct by any Player, and the Committee may after due inquiry, impose any further sanctions and penalties over and above the mandatory penalties. When disciplinary action is taken against any Player by way of a composition fine or referred to the Disciplinary Committee for further sanctions, the yellow/red cards accumulated by the said Player shall not be considered for further sanctions.
- 45.1.10. The Club and Player shall be responsible for monitoring the record on the yellow and red cards and suspensions accumulated by their respective Players in the respective tournaments.
- 45.2. All sanctions and/or penalties shall commence with immediate effect except in cases where the FAS Competitions Committee or the Director, Competitions may otherwise decide, and all fines including composition fines imposed shall be paid in full within seven (7) days from the date the penalty/sentence is imposed before the said Player can participate in any Match of a Competition in which the offence was committed. For the purpose of these Regulations, all tournaments organised by the FAS shall fall under the Regulations.
- 45.3. All sanctions and/or penalties under this rule shall be served out or complied with in full during the Competition in which the offence or offences were committed by the Player/Team Official. If the sanctions and/or penalties cannot be fully served or complied with in full, it shall be deferred only to the following Season of the same Competition where the said Player/Team Official is registered and eligible.
- 45.4. Red card and yellow card cautions shall not be accumulated to the following Season of the Competition or to any other Competition organised by FAS.
- 45.5. Any disciplinary measures imposed by the Referee on the Field of Play are final with exceptions being made for possible modifications arising from corrections made to the Referee's Report or if obvious mistakes have been made.
- 45.6. The FAS has the power to take retrospective action for potential Red Card offences if not fully seen by the Match Officials. The FAS may also take appropriate action even when an incident has been witnessed or acted upon by the Match Officials in serious or unusual circumstances.
- 45.7. If the referee sanctions (either caution or expulsion) at least five (5) members of the same team (refers to Players and Officials registered under a Team Official Delegation) during a Match, the Club shall be fined Five Hundred Dollars (SGD\$500.00) per expulsion and Two Hundred Fifty Dollars (SGD\$250.00) per caution. Further disciplinary measures may also be taken against the Club concerned.

#### **46. Fielding of Minimum Eleven Players at Point of Kick-Off**

- 46.1. In the exception of extenuating circumstances, any Club that is found guilty of failing to field a minimum of eleven (11) starting Players at the point of kick-off for their Matches, shall at the discretion of Director, Competitions, on its first offence, be fined up to Five Hundred Dollars (SGD\$500.00) and/or referred to the FAS Disciplinary Committee, who may after due inquiry impose sanctions and/or penalties over and above the mandatory sanctions and/or penalties on the Club.
- 46.2. On the Club's second offence, the Club shall be fined up to One Thousand Dollars (SGD\$1,000.00) and/or referred to the Disciplinary Committee, who may after due inquiry impose sanctions and/or penalties over and above the mandatory sanctions and/or penalties on the Club.

- 46.3. On the Club's third offence, the Club shall be expelled from the League and any further participation in the League, in accordance with Article 7 and its sub-articles.

#### **47. Minimum Required Players for Match**

- 47.1. A Match shall not start or continue if either team consists of fewer than seven (7) Players including the goalkeeper.
- 47.2. In the exception of extenuating circumstances, any Club that is found guilty of failing to field a minimum of seven (7) starting/fielded Players at the point of kick-off, or at any point of time during their Match, causing the Match to be called off, shall at the discretion of Director, Competitions, on its first offence, be fined up to One Thousand Dollars (SGD\$1,000.00), Also, three (3) points shall be awarded to the opposing non-infringing team, and the score of the Match concerned to remain/or a three (3) – nil (0) shall be awarded to the said non-infringing team, whichever is greater.
- 47.3. On the Club's second offence, the Club shall be expelled from the League and any further participation in the League, in accordance with Article 7 and its sub-articles.

#### **48. Team Kit and Colours**

- 48.1. Any Club that is found guilty of failing to adhere to the team kit officially registered by the club shall, at the discretion of Director, Competitions, be fined a minimum of Five Hundred Dollars (SGD\$500.00) and/or referred to the Disciplinary Committee, who may after due inquiry impose sanctions and/or penalties over and above the mandatory sanctions and/or penalties on the Club.
- 48.2. Any Club that is found guilty of failing to adhere to the team colours indicated in the Player Selection List, or failed to produce a second set of kits upon request from the Match Officials shall, at the discretion of Director, Competitions, be fined a minimum of Five Hundred Dollars (SGD\$500.00) and/or referred to the Disciplinary Committee, who may after due inquiry impose sanctions and/or penalties over and above the mandatory sanctions and/or penalties on the Club.

#### **49. Captain Armband**

- 49.1. The captain of the team shall wear the armband issued by the FAS Competitions Department to indicate his status.
- 49.2. Pursuant to the above, a Club whose captain fails to wear the armband issued by the FAS Competitions Department shall be fined a sum of One Hundred Dollars (SGD\$100.00).

#### **50. Post-Match Handshake**

- 50.1. Players from both the teams are required to assemble at the centre circle with the Match Officials for a post-match handshake. Any Player who fails to do so shall be issued with a mandatory fine of One Hundred Dollars (SGD\$100.00).

#### **51. Smoking & Littering**

- 51.1. All Clubs shall be required to maintain cleanliness of the Match venue at all times, including the technical areas, changing rooms, toilets, Field of Play and any other areas within the Match venue.
- 51.2. Smoking/vaping is strictly prohibited within the vicinity of all Match venues. Should any Player be caught smoking/vaping and/or any Club and/or Player be caught littering within the vicinity of the Match venue, the Player and/or the Club respectively shall be fined a sum

of Three Thousand Dollars (SGD\$3,000.00) and/or be referred to the FAS Disciplinary Committee for further sanctions.

- 51.3. All decisions made by the FAS Competitions Department and/or FAS Disciplinary Committee in this regard are final and binding.

## **52. Disparaging Remarks on Refereeing / Charging at Referees / Conduct of Club Officials and Players**

- 52.1. No Official, Coach, Player, or a member of the Team shall make any disparaging remarks about the refereeing of a Match; any such remark made by an Official, Coach, Player or a member of the Team may render such person liable to disciplinary action.
- 52.2. No Official, Coach, Player, or a member of the Team shall make any abusive/offensive remarks towards any appointed Match Referee/Match Commissioner/Referees Assessor of a Match; any such remark made by an Official, Coach or a member of the Team may render such person liable to disciplinary action.
- 52.3. No Official, Coach, Player, or a member of the Team shall charge at and/or display improper conduct towards any appointed Match Referee/Match Commissioner/Referees Assessor before, during or after the game, for whatever reasons. Any such action shall render the Official, Coach, Player, or a member of the Team and Club concerned liable to a fine at the discretion of Director, Competitions and/or referred to the FAS Disciplinary Committee.
- 52.4. Any Official, Coach, Player or a member of the Team who fails to conduct oneself in a proper and responsible manner before, during or after the game, including but not limited to misconduct on the Field of Play, in the technical area, dressing rooms and stadium premises, shall be liable to disciplinary action.

## **53. Payment of Sanctions, Offer of Compositions & Fines**

- 53.1. All payments of sanctions, offer of compositions and fines imposed to a Club, Player or Official shall be made within the deadline stipulated in the notice of sanctions/offer of compositions or fines.
- 53.2. After the expiry of the notice issued, and the Player or Official have not made the full payment of the sanction/offer of composition or fine, the Player or team Official shall not be allowed to participate in any Matches in the League until the full payment has been received. The case may also be referred to the FAS Disciplinary Committee for further action.
- 53.3. After the expiry of the notice issued, and the Club have not made the full payment of the sanction/offer of composition or fine, the Club shall be referred to the FAS Disciplinary Committee for further action and not be permitted to participate in the League until the conclusion of the FAS Disciplinary Committee inquiry or full settlement of their outstanding fine.
- 53.4. Pursuant to 53.3, for all Matches which the Club has caused to be called off, three (3) points shall be awarded to the opposing non-infringing team, and the score of the Match concerned to remain/or a three (3) – nil (0) shall be awarded to the said non-infringing team, whichever is greater. At the discretion of the FAS Competitions Committee, the infringing Club may be referred to the FAS Disciplinary Committee for further sanctions.
- 53.5. All payments of sanctions, offer of compositions and fines which are issued shall not be allowed to be deducted from the WPL Financial Subsidy, unless the Club's claim for WPL Financial Subsidy has been approved.

## **54. Compounding Offences**

- 54.1. Without prejudice to the Regulations hereinbefore, the Director, Competitions, is empowered to compound any offence, misconduct or breach of these Regulations of these Sections

committed by a Player, Team Official or Club to a maximum limit of Five Thousand Dollars (SGD\$5,000.00) and/or a suspension of up to a maximum of two (2) Matches and/or awarding a win by default, in which case a score of three (3) - nil (0) shall be given, unless the goal difference attained in the Match is greater in favour of the non-infringing Club.

#### **55. Disputes Involving League Clubs**

- 55.1. Any dispute, question or difference or matter affecting Clubs, Officials or Players or Members shall be referred to the Director, Competitions, who has powers to adjudicate, determine or resolve it himself or refer the same as per the provisions of these Regulations.

#### **56. Prohibition to Recourse to Ordinary Court**

- 56.1. Pursuant to Article 58 of the FIFA Statutes adopted at the Extraordinary Congress in Zurich on 18 September 2020 and which came into force immediately after adoption, Clubs and members are prohibited from taking a dispute to ordinary courts of law and are required to submit any disagreement to the jurisdiction of the Association (FAS), AFC or FIFA.

## SECTION F: ADMINISTRATION

### 57. Prize Money and Awards

57.1. The FAS shall pay and award the following:

#### 57.1.1. Women's Premier League

57.2. The FAS shall present the following awards after the conclusion of the League:

- 57.2.1. Player of the Year;
- 57.2.2. Young Player of the Year;
- 57.2.3. Coach of the Year;
- 57.2.4. Golden Boot Award;
- 57.2.5. Golden Glove Award;
- 57.2.6. Goal of the Year; and
- 57.2.7. Fair Play Award

57.3. Pursuant to the above, the FAS shall provide the voting mechanism and criteria for each award to all Clubs after the conclusion of the League.

### 58. Champions of the Women's Premier League & Women's Challenge Cup

58.1. The Winners of the Women's Premier League and the Women's Challenge Cup shall receive the Championship Trophy from the FAS. Additional souvenirs may be presented by consent of the FAS, such as replica trophies.

58.2. The Championship Trophy shall be presented to the winner of the League, but the trophy shall remain the property of the FAS. The Champion Club shall hold the trophy until two (2) months before the end of the following season's competition, when the Club shall return the same trophy in good order and condition to the FAS. However, the FAS reserves the right to recall the trophy from the Club whenever it deems necessary.

58.3. Should any of the trophies be lost, destroyed or damaged by fire or by any other cause whilst under the care, control or custody of the Club, the latter shall refund to the FAS the amount of the total cost or through repair and outgoings in addition to any other penalty which FAS may impose.

### 59. External Match Arrangements

59.1. Clubs shall not arrange Matches, which will interfere or disrupt the Match Schedules. Clubs desiring to stage representative or friendly matches shall obtain prior approval from Director, Competitions and obtain the required sanctions.

### 60. Breach

60.1. Any breach of these Regulations in these Sections (notwithstanding that it may not have been so expressed) shall be deemed misconduct, and the Club, Player or Official, as the case may be, or a member of the Club, shall be referred to the Disciplinary Committee or the appropriate

Committee, through the Director, Competitions, for appropriate action as that Committee deems fit at their absolute discretion.

- 60.2. With accordance with Article 54.1, the Director, Competitions, shall, at his absolute discretion, compound offences, where applicable, for any breaches of these Regulations in these Sections by Officials and/or Players or any other Member of the Club.

### **61. Special Instructions**

- 61.1. The FAS shall issue any instructions necessitated by special circumstances which might arise in the organization of Matches.

### **62. Decisions**

- 62.1. All decisions made in accordance with these Regulations, except where expressly identified otherwise, are final and binding.

### **63. Amendments**

- 63.1. The FAS reserves the right to make amendments to any part of these Regulations for any reason whatsoever. The Director, Competitions or the Competitions Committee, where applicable, reserves the right to change the date of the Matches, venues, or any of these Regulations. Such amendments shall be duly communicated in due course.

### **64. Force Majeure**

- 64.1. The Exco is the only body capable of declaring a Force Majeure event.

### **65. Matters Not Provided For**

- 65.1. Any matter not provided for in these Regulations, shall be dealt with by Director, Competitions or where relevant by the Competitions Committee, whose decision shall be final and binding and not subject to appeal.

### **66. Closing Provisions**

- 66.1. The FAS is entrusted with the operational management of the Competition and is therefore entitled to make decisions and adopt the detailed provisions necessary for implementing these Regulations.
